Data Lineage requirements are an additional burden, typically made more difficult by the volume of changes needed in order to file accurately.

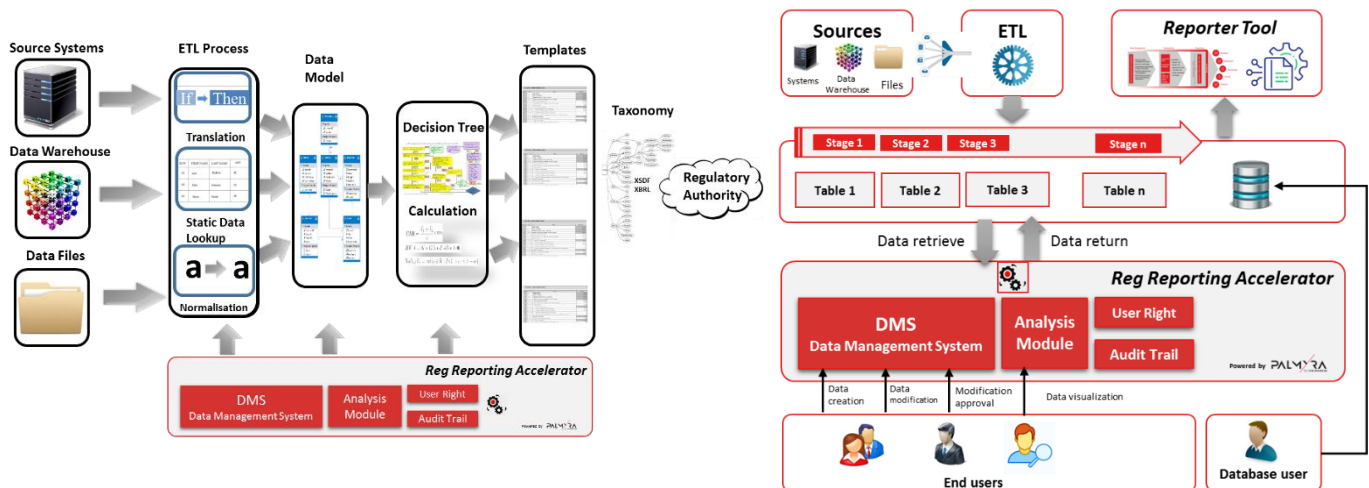

The Regulatory Reporting Accelerator automatically generates the data model (UML including the mapping), and the screens. It provides multiple features such as 4-eye validation, security management and audit trail by default.
